REQUIRED DOCUMENTS

Proof of Identity

In order to comply with our regulatory requirements, each applicant for membership must supply us with a valid passport **and** one of the four documents. These must bear your signature and your photograph.

- o Valid Passport (preferred)
- o Driver's Licence
- o National Voter's Identification Card
- o Social Security Card
- o Medical Benefits Card

(The certified copy must clearly show the photograph, signature and expiry date).

A current job letter from your employer and or valid work permit is required.

Self-employed persons should show proof of occupation e.g. business licence.

In addition, we also require confirmation of your permanent residential address. This may be demonstrated on anyone of the following documents and should be an original not more than three (3) months old.

- o Utility bill **e.g.:** water, electricity, telephone, internet or cable
- o A recognised bank or credit card statement

Please note that non-bank cards such as store cards, mobile telephone statements or addresses that feature "Care of" are not acceptable as confirmation of your residential address.
